Periodic Review of Safe Return Plan

- Elementary and Secondary School Emergency Relief Fund (ESSER III Fund) received from the federal government require school districts to periodically review and revise the plan for safe return to in-person instruction and continuity of services at least every six months
- Additionally, requires the district to take public input during the review process
- Public input process
 - Will post the updated plan on the district website at www.elchoschool.org
 - Share the plan at the School Board meeting on September 20, 2022. There would be the opportunity for public comment at the board meeting.
 - Revise if needed based on feedback

Elcho School District Commitments

- In-person instruction five (5) days a week will be the sole option for students and families
- Encourage staff members and students to stay home if they are not feeling well
- Will provide families with a free COVID test if they would like one, not a requirement
- Encourage frequent hand washing
- Maintain the cleaning schedule the district has been utilizing
- Continue to work with Langlade and Oneida County Health Departments for updates

In the event there is an outbreak, Langlade County Health Department has the ability to shut the district down, as we would need to comply

WI Department of Public Instruction Guidelines

Elcho School District will follow guidelines includes the following:

- Removal of recommendation to cohort students
- No social distancing requirement
- No requirement to contact trace or notify families
- Asymptomatic individuals do not need to quarantine
- Remove the recommendation to quarantine individuals
- Not conducting screening tests
- Emphasize identifying and keeping ill students and staff from attending school. This would include any student with a fever, vomit or nausea, as has always been the tradition of schools
- Encourage parents to test their child for COVID-19 if they are showing symptoms
- If a student/ staff member tests positive they should stay home for at least 5 days, can return day 6

Langlade County Covid Information

If Test Positive for COVID-19

- Stay home for 5 full days (day 0 is the first day of symptoms or positive test date if no symptoms)
 - Must be fever free, vomit & diarrhea free for 24 hours without medication
 - Other symptoms must be improving
- Wear a mask for 5 additional days (days 6-10). If unable to mask you should isolate for 10 days.
- Notify close contacts that you have COVID-19

If Exposed to COVID-19

- Watch for symptoms for 10 days
- Wear a mask for 10 days
- If symptoms develop within 10 days, isolate and get a COVID-19 test
- Regardless of symptoms, get a COVID-19 test on day 6
- If negative, continue to mask through day 10
- If positive, follow above guidance

What we will do of the County's recommendations

If an individual would Test Positive for COVID-19

- Stay home for 5 full days (day 0 is the first day of symptoms or positive test date if no symptoms)
 - Must be fever free, vomit & diarrhea free for 24 hours without medication
 - Other symptoms must be improving
- Recommend (Not Required) Wear a mask for 5 additional days (days 6-10).

If Exposed to COVID-19

- Watch for symptoms for 10 days
- Recommended (Not required) to wear a mask for 10 days
- If symptoms develop within 10 days, isolate and get a COVID-19 test
- If positive, follow above guidance

Elcho's response

As a district we will continue to:

- Emphasize identifying and keeping ill students and staff from attending school. This would include any student with a fever, vomit or nausea, as has always been the tradition of schools
- Encourage parents to test their child for COVID-19 if they are showing symptoms
- If a student/ staff member tests positive they should stay home for at least 5 days, can return day 6
- Clean and disinfect classrooms and surfaces
- Provide good ventilation
- Encourage washing hands and use of hand sanitizer
- Consider COVID-19 Community Level for the county - currently Low
- Have parents monitor their children for signs of infectious illness every day
- Send home children who have a fever, vomit or diarrhea
- Provide FREE COVID-19 tests to families if they want to test
- Respond to an outbreak and work with the county
- Not require anyone to wear a mask. Masks would be recommended for individuals returning on day 6 - 10 or if symptomatic, but this will not be enforced
