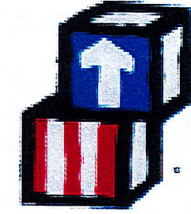

What is Head Start?

Head Start is a federal program that promotes the school readiness of children ages birth to five from low-income families by enhancing their cognitive, social, and emotional development.

Head Start programs provide a learning environment that supports children's growth in the following domains:

- Approaches to Learning
- Social and Emotional Development
- Language and Literacy
- Cognition
- Perceptual, Motor and Physical Dev.

Head Start emphasizes the role of parents as their child's first and most important teacher. Head Start programs build relationships with families that support:

- Family well-being and positive parent & child relationships.
- Families as learners and lifelong educators.
- Family engagement in transitions.
- Family connections to peers and community.
- Families as advocates and leaders.

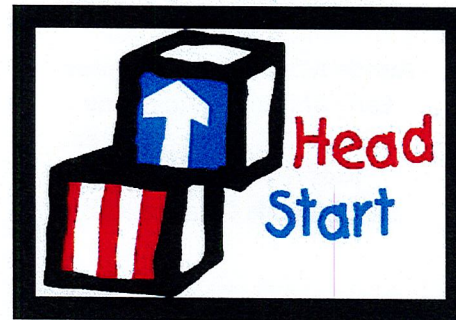
Program Options

Head Start Program Options:

- **Center Based Part-Day:** Provides a classroom experience 4 days per week, 3 ½ hours per day.
- **Center Based Extended Day:** Provides a classroom experience 4 days per week, 7 ½ hour per day.

Early Head Start Program Options:

- **Center Based:** Full year Center Based Programming is offered 4 days per week, 7 ½ hours per day.
- **Home Visitation:** Provides families with weekly home visits and bi-weekly socialization activities.

Who is Eligible?

- Families with children from ages birth to five.
- Must meet federal low-income guidelines.

Applications and acceptance into the program are based on Eligibility Selection Criteria as outlined in the federal regulations and approved by the Policy Council. Family & Child Learning Centers serves 90% income eligible children and allows for up to 10% over income children.
